2023 Grant Applications

Weed & Pest Department Monthly Update:

The Weed & Pest shop is all closed up for the season. Chris Hemen is back in the State's Attorney's office for the winter. Mike Rohrbach and Jerry Lehrkamp are both back in the highway shop. Hemen also wanted to thank Aberdeen Parks and Rec for helping us store our chemical in a heated shop over the winter.

The District 1 meeting for the SD Association of Weed & Pest Boards was held in Stratford on November 2nd with all Brown County Weed & Pest employees in attendance. Bill Donaldson also attended and gave an update. He stated it was very informative.

Brown County has been working with Aberdeen's code enforcement officer, Paula Nelson, regarding some noxious weed complaints within the city limits. Paula has also been a big help to the Weed & Pest shop in regards to some other noxious weed concerns we've had and helped us arrange for a test plot for yellow toadflax that is being conducted by SDSU.

Chris Hemen met with the Brown County Commissioners this morning to give them an update on how things went for the year. He stated he appreciates that we have a commission that understands the importance of having a dedicated Weed & Pest program for the county.

Other Matters

Local Noxious Weed Designation

The designation for yellow toadflax and bull thistle as local noxious weeds is expiring in 2023. Tyler Bierman motioned that we request the SD Weed & Pest Commission designate yellow toadflax and bull thistle as local noxious weeds for Brown County. Seconded by Bill Donaldson, motion passed.
