Public Presentation Day



Poultry Information

Poultry Exhibitors: We are excited to have you participate in the poultry program for the 2019 4-H year. As the program continues to grow in interest please be diligent as you prepare your poultry exhibit for summer shows that your animal ownership is accurate.

Legs Bands are a required form of ID for Poultry exhibited at the Brown County Fair and South Dakota State Fair. Leg Band inaccuracy between 4-H Online, FairEntry, and Check-in at both fairs will be an automatic disqualification of show and loss of premiums for that exhibit. Also, understand that not all breeds that are available for purchase at TSC, Runnings or other farm stores can be shown in 4-H. If you are wanting a list of breeds, please let the Brown County 4-H Office know and we will make sure that you get them. Please contact the Brown County 4-H Office with any questions that you may have.



Important Livestock Information

- Affidavits will be for unofficial use ONLY—this means it will not be accepted for State Fair Exhibition/Eligibility. It will still be accessible to collect animal info at home. You can then use it to enter your info on 4HOnline, or bring it to the 4-H Office for assistance entering it online.
- **NOTE:** 4-H Dog Project ID Affidavit and Vaccination Verification form is required for dog projects as a veterinarian's signature is required. Horse Form and Horse Achievement Form are required forms that must be completed to enter in the horse project area. The deadlines for these forms are June 1st.
- 4-HOnline data entry for 4-H animal identification is the <u>exhibitor's responsibility</u> to upload into 4HOnline <u>no later than June 1st</u> at 11:59p.m. If you do not have access to the Internet or do not know how to upload info to 4HOnline, there will be a class held at the 4-H Office May 18 from 9am-12pm. Please call to make arrangements if this date does not work for you. There are also step by step instructions available on 4HOnline.

IMPORTANT NOTE: Enrolling Animal Projects as a Family:

• In helping to avoid confusion and the entry of multiple animals, please enter an animal only 1 time into 4HOnline for your FAMILY. Pick one child--we suggest the youngest for animals that can return to fairs for multiple years--and enter all the animals for your family under that one child. Members of that family will have the option to show any animals listed under any of their family members and the animals will still appear for each youth in the family in Fair Entry. When an animal is selected for registration in Fair Entry, it will disappear from the list of available animals to select in future registrations for the family. This is not the case if the animal is registered under multiple kids. The animal it will not disappear from the list of available animals, as Fair Entry sees each animal entered in 4HOnline as a separate animal; therefore, allowing a family to select the same animal for more than one child.

• **EXAMPLE:** If you have two children, John and Susie, and you have four animals, you would enter all four animals under John and enter no animals under Susie. When it comes time to enter John and Susie in Fair Entry, all 4 animals would show up for John and Susie. Once you have entered animal 1 for John, that will be taken off the animal list and will show as already used when showing the list for Susie. You can then select any of the three remaining animals. For the fair, the animals will be listed under the child whom they were picked for, not the child they are in 4HOnline under.

- Initial weight for market animals is no longer required to participate at the State Fair.
- DNA collection is the **<u>exhibitor's responsibility.</u>**
- Animal registration papers are the <u>exhibitor's responsibility</u> to upload to 4HOnline by <u>July 1st</u> at 11:59p.m. If this deadline is missed, the animal will be shown as commercial. There are no exceptions.



Green NUES Tags

Here is some clarification for using **Green NUES tags** on market animals. Only Market Steers, Market Swine, and Market Heifers that **DO NOT** have a Bangs tag should be tagged.

- If a heifer has Bangs tag, do not give her a Green NUES tag
- Market Lambs, Market Goats, and Breeding Goats should have Scrapie tags (NUES tags). The number must be entered in 4HOnline.
- Dairy Goats should have a Scrapie tag, but if she does not, please make sure an individual ear tattoo is entered in 4HOnline.
- Rabbits must have an individual ear tattoo. The number must be entered in 4HOnline.
- REGISTERED Breeding Heifers must have a tattoo that corresponds to her Registration Papers. The number must be entered in 4HOnline.
- Dairy Cattle must have a Bangs tag, a Registration number, Tag, a NUES tag or an individual ear tattoo. This must be entered in 4HOnline.
- COMMERCIAL Breeding Heifers must have a Bangs tag or Green NUES tag. The number must be entered in 4HOnline.
- All Market Swine should be Green NUES tagged unless they have a NUES Premises tag with a USDA seal on it. The number must be entered in 4HOnline.
- Poultry must have a leg band with color and number entered in 4HOnline as soon as the information is available.

If an animal has a federal tag with the USDA shield, DO NOT put another NUES tag in its ear.



IMPORTANT DATE INFORMATION

- DNA Sample
 - ALL market animals MUST have a DNA sample self-identified by youth/ families
 - Samples are DUE to the county office by May 31st
- Lease forms (Deadline: May 31st)
 - All required signatures are completed
 - Animal Identification is completed accurately
- Horse achievement forms (Deadline: June 1st)
 - Check to make sure all information is correct
 - Check for all required signatures
 - MUST be completed by June 1 for South Dakota State 4-H Horse Show eligibility
- Horse Form (Deadline: June 1st)
 - Photos of the horse must be uploaded as part of the Horse Form
- Dog Project
 - Require a veterinarian signature
 - Photos of dog must be uploaded as part of the Dog Project ID Affidavit & Vaccination Verification
- YQCA Certification (Deadline: June 1st)
- Registration Papers (Deadline: July 1st)
- At achievement days/county fair ensure all animal information is correct on 4HOnline

*****It is CRUCIAL ALL information in 4HOnline is double checked for correctness at the county qualifying event so that as the data gets transferred for State Fair, all animal details are correct

*****Please note that June 1st is a Saturday this year so any forms or DNA that needs to be turned into the 4-H office <u>must be done before 5pm on May 31st, 2019</u>



YQCA Information—Mandatory Training Required

YQCA certification is being accepted by many livestock shows and fairs that require youth quality assurance certification. View the list here, but always check the entry requirements of each show for complete details. Youth for the Quality Care of Animals (YQCA) is a national multi-species quality assurance program for youth ages 8 to 21. The program is designed to provide an estimated 60 minutes of education each year. The online program requires the passing of a series of three quizzes to earn certification. An in-person YQCA workshop requires complete attendance. YQCA is the result of a collaborative effort between states that have previously offered multi-species youth livestock quality assurance programs, the National Pork Board's Youth PQA Plus program and representatives from other national livestock groups.

YQCA includes information for youth showing the following food animals:

Pigs	Goats
Beef Cattle	Rabbits
Dairy Cattle	Poultry

Sheep

YQCA is available as an online or face to face program for youth everywhere in the United States. YQCA in-person workshops may be available to youth where state 4-H or FFA offices or state/national livestock organizations have partnered to have qualified trainers offer in-person workshops. Brown County's LAST face to face training date is:

• May 30th - 4pm at the Aberdeen Extension Regional Office (13 2nd Ave SE)

To sign up for face to face dates or to take the program online you must use the following link: <u>https://yqca.learngrow.io/Account/Login</u> There are help sheets for each type of training option available on 4HOnline. You will need to be prepared to pay for the cost of the YQCA training when you register in the system. Only credit cards are accepted. The cost is \$12 for taking the course online and \$3 for a face to face session. It is highly recommended to attend a face to face session, if possible.

**This training is mandatory for all youth showing the above listed animals at both the county and state levels. You will NOT be able to show at the county or state fair without completing this training.
